--Demand that they pass and deliver to him a bill of TOTAL and IMMEDIATE abolition of abortion (since 75% of Oklahoma legislators claim to be pro-life), --Sign that bill into law immediately, and --Instruct all state agencies to ignore and defy any challenges from the federal government, including the Supreme Court.

Oklahoma could have been the first ABORTION-FREE state.

Instead, you did nothing of substance.
